### **FUND OVERVIEW:**

The Conquer Risk Tactical Rotation Fund (the "Fund") actively allocates assets across equity and fixed income ETFs overweighting those investments that exhibit the best risk-to-reward ratio. If the Advisor's algorithmic composites point to a rising market, the Fund may have a higher proportion of equity ETFs. During a downward trending market, the Advisor will limit the Fund's investments to low volatility ETFs, and cash in an effort to reduce downside exposure. Specialty investments, such as leveraged and inverse ETFs, may be used from time to time to hedge risk and provide for smoother returns. Risk-managed policies employ the use of cash during adverse conditions; these positions could at times be 100%.

The Growth of \$10,000 graph shows a fund's performance based on how \$10,000 invested in the fund would have grown over time with dividends reinvested


